Microenterprise Grant Program

- The one last remaining piece of the program, the educational section, came together last month early this month.
- From the presentation last month where we expected 8- 10 and had 28. that dwindled down to 18-20 people that completed 12 hours of educational training over a 4 consecutate night period.
- From that so far we have had 5 applications come in and we submitted our first one to the county for submission to the stae for draw down.
- The grants will range between \$5,000 \$25,000.
- The majority of the participants were about 50/50 from Johnstown and Gloversville
- If everything goes as planned, there will be approximately 15 jobs over the next year or so.
