Public Session

Call to Order / Introductions/Meeting Minutes:

Chair Greg Fagan called the meeting to order at 8:48 a.m. He welcomed the Directors and guests to the meeting. Greg asked for a motion to approve the meeting minutes from June 30, 2017, along with the attached Finance Committee Meeting Minutes from June 28, 2017. Geoff Peck made the motion; Kent Kirsch seconded the motion and it passed unanimously.

Administrative Matters

Chair Report:

Chair Greg Fagan said that the Euphrates tour went well. He and the Board agreed that they make the best feta cheese. He reminded everyone that the Versatile Wood tour is next up in August.

Committee Reports:

Executive Committee: This Committee has not met since the last Board meeting.

Governance Committee: This Committee has not met since the last Board meeting.

Finance Committee: Ron Olinsky advised the Board that this Committee met the Wednesday prior to the Board Meeting and that they also met with Phil Beckett on July 11th for some clarification on his reports.

On July 26th, they reviewed the bank balances, Phil Beckett's report, the year-to-date numbers for the 34 West Fulton Street building, and the loan pool report. Nothing is out of place.

Audit Committee: This Committee has not met since the last Board meeting.

Building Committee: This Committee has not met since the last Board meeting.

Membership & Marketing Committee: Grant Preston said that scheduling a summer meeting has been difficult. Therefore, this Committee has not met since the last Board meeting.

Gloversville Downtown Development Specialist Report:

Jennifer Jennings provided a written report to the Board prior to the meeting. She provided updates on The itinerary for the August 11th Twilight Market, advised the Board that around 450 people were present at the July 14th Market, and gave updates for the October 7th Bacon Jam in Bleeker Square. She mentioned that she is looking for sponsors, planning committee members, and vendors for this event. She also advised them that the August 1st National Night Out event went well. The CRG tent had a sign making event: What Makes Gloversville Special, which lots of children participated in during the evening.

County and City Reports:

Craig Talarico said that the City of Johnstown feels that the annexation issue with the Town of Mohawk is moving along well.

Jim Mraz handed out the newly published Fulton County Profile booklet, which will be used as a marketing tool and is on the County's website. He will get an electronic copy to CRG for the fccrg.org website. He said that the County is sending out an e-newsletter 6 times a year and shared a sample with the Board. He spoke about an RFP that the County is putting out for a hotel need analysis. He explained the County's 2018 marketing efforts and a real property tax law, 45B incentive, which he feels could be a business marketing tool.

President and CEO Report

Current Projects: Ron Peters informed the Board of current projects that he has been working on. These include: a large manufacturer in the Industrial Park that is closing on another park building; a small expansion in the Industrial Park; interest in the Regional Park; and a company potentially interested in the Crossroads Industrial Park.

Microenterprise Grant Programs: Ron advised the Board that the 2016 Microenterprise Grant Program will sunset at the end of 2017. He listed the companies that have received funding so far. The County plans to apply for a 2018 microenterprise grant through the CFA application process as there is more interest in the program than can be met with the current funds.

Community Outreach Programs: Ron reported that the Euphrates tour was a great success. The next tour will be Versatile Wood in August. Ron urged all in attendance to RSVP.

The Caroga Lake Committee has completed their course of work and has recommended a project to the Town. The Town Board has agreed to meet with the group.

The Village of Northville said that their July Woodworking Festival was one of the best they have had to date. Ron continues to assist them with their \$500,000 Main Street Grant and business advisory panel with the School District.

The Governor's response to the City of Gloversville's DRI application has not been given yet. A regional developer interested in Gloversville invited several Gloversville officials to look at some completed projects nearby. Ron and Scott Hohenforst went to represent CRG. Scott spoke to the Board about how impressed he was with the job that they have done.

Ron said that Townsend Leather's plan to purchase the former knitting mill in the City is gaining support as they move forward.

Business Marketing Inquiries: Ron listed the business which he spoke to that are interested in Fulton County. As well as those that he has followed up with

There were four 310 calls scheduled this month but three of them fell through; Ron suspects that summer time off is to blame.

Combined County Marketing Effort Update: Ron met with Jim Mraz and Jon Stead; they continue to work as a team on joint marketing efforts; they will now begin to finalize their plans for the Site Selectors Visit in September.

Property Disposition Update: Estee Phase II at 90 North Main Street has been completely demolished now. They are holding a groundbreaking ceremony on August 2, 2017. Ron has put the vacant land along Littauer Place on hold for the moment due to other deadlines.

Loan Applicant Updates: Ron expects one loan application to come in that could be done in combination with MORECO and/or GEDC.

2017 Proposed Events: Remaining on the agenda for 2017 are the following events: a six county Business Financing Symposium geared toward small to medium sized businesses (which will be moved to the fall), Site Selectors Guild Event, and a fall CRG Event.

2017 Events Attending: Ron explained that there are two IAMC and Site Selector Guild events per year, one in the spring and one in the fall. He described what happens at them and how the state's attitude has changed into a positive regarding attending them.

34 West Fulton Street: Ron talked about 2 potential tenants coming into the building

National Grid Marketing Grant: CRG will be drawing down funds from the completed marketing grant.

Adjournment to Executive Session to Discuss Legal Issues

At 9:26 a.m. Greg Fagan asked for a motion to adjourn the meeting to Executive Session. Ron Olinsky made the motion; it was seconded by Grant Preston and unanimously approved. Greg dismissed the guests and thanked for their attendance at the Board meeting.

Legal Issues:

The Directors discussed several ongoing legal issues. These discussions were informational in nature. No action was needed.

Becky Hatcher was asked to leave the meeting around 10:00 a.m. No further minutes were recorded.

Call to Order

Ronald Olinsky, Treasurer, called the meeting to order at 8:03 a.m.

Meeting With Phil Beckett, CPA

The Committee had asked Phil to meet with them regarding program revenue and the future of CRG. Mr. Beckett advised them of the way that salaries and revenues look on his reports. He mentioned that the timing of things, like receipt of county funding, effect his numbers. He also clarified what makes up program revenue: Fulton County contract, membership, grant income, and annual event income.

Mr. Beckett said that, at six months into the year, CRG is on trend with their budget. This is with the understanding that the Site Selector and CIREB event expenses will be at least partially reimbursed by the County funding and an outside grant.

The Committee talked about how the rent generated by tenants at 34 West Fulton effects the budget. They also considered expenses for the building, including fit-up of spaces.

They concluded with the request that Mr. Beckett provide them with a new year-end projection. He said that he may also give them an additional report that contains more specific information for the budget vs. actual numbers. The Committee also requested an income vs. expense report for Jennings' position at the next meeting.

Adjournment

As all agenda items had been covered, Ron Olinsky adjourned the meeting at 8:25 a.m.
