Message from CRG's President and CEO

I'm pleased to report that 2016 turned out to be CRG's best year ever. This could not have been achieved without the continued support and work of our Board of Directors, the Fulton County Board of Supervisors, the many other elected officials, local business leaders, and our members. We had the good fortune of participating in many New York State Economic Development Events and reaching out to our neighboring counties to build alliances which will further support Fulton County's marketing and economic development efforts.

We moved into our new facility this year!! On March 16, 2016, we accepted the donation of 34 West Fulton Street from the previous owner, OHM Laboratories, and on April 1st, we moved into our new facility in Downtown Gloversville. We occupy part of the first floor of the building and have applied for several grants through state agencies to help renovate the property into a Downtown Business Center/Incubator to help support economic growth in Fulton County. In 2016 we were awarded a \$300,000 state grant through Senator Farley's office and a \$50,000 grant from National Grid. We haven't received actual dollars yet, but are currently in the process of getting into the drawdown process.

During the course of the year we visited over 50 Fulton County Businesses to thank them for being in the county. We looked at what future needs their business model may require and offered to assist them with any business needs they currently had. These visits helped give us tremendous insight as to what most businesses generally need to succeed and helped generate ideas and methods to provide help to businesses.

2016 saw a growth in our original 2013-2015 Microenterprise Grant Program. That program closed with 8 successful applicant's generating at least 19 jobs within Fulton County. Additionally, in 2015, New York State approved another Microenterprise Grant which was rolled out in 2016. This second Microenterprise Grant received 5 applications which are in various stages of completion. Next year this program will start generating results.

Working in conjunction with the Fulton County IDA, CRG put together financing packages allowing New Age Renewable Energy, LLC. to start construction a new facility in the Johnstown Industrial Park. When complete in 2017 they will have created 22 new jobs.

This year CRG attended several strategic industry tradeshows promoting and marketing Fulton County and all it has to offer to existing and start-up businesses.

The outlook for 2017 is great and I am happy to work with each and every opportunity to promote Fulton County and expand our economic base.

During 2016, CRG accomplished the following activities; described per funded category:

Professional Staff

CRG's 2016 staff consists of two full-time employees, Ronald Peters and Becky Hatcher, and two part-time employees, Katherine Crankshaw and Diane Harnish. During FMCC's fall semester, CRG hosted an intern, Paul Davis, who assisted with accounting duties.

Website/Internet Promotion

CRG continues to utilize the assistance of Shannon-Rose Design for website maintenance and enhancements. Shannon-Rose also managed CRG's social media presence through facebook and twitter. During the year, CRG's website was enhanced to include an events page. This will allow visitors to the site to view upcoming and past events. It includes pictures of event activities where applicable.

Business Marketing

During 2016, CRG began to utilize the email service, Constant Contact, to reach out to a variety of contacts in various business and industry segments. Examples of email content varied from local events which went to regional contacts to press releases regarding activity in our Industrial Parks which were sent to national site selectors.

Market Shovel-Ready Sites and Business Recruitment

Ron Peters attended several national conferences during 2016, all targeted to expose Fulton County to national site selectors and heads of national corporations with the goal of developing relationships that have the greatest prospect of bringing jobs and tax revenues into the Business and Industrial Parks in Fulton County. CRG also obtained matching grant funds from National Grid toward the purchase of a trade show booth and other trade show items which will be used during 2017 events.

Within the Johnstown Industrial Park, Ron continued to work closely with New Age Renewable as they prepared to break ground on their upcoming whey waste disposal site.

Community Development Marketing

Ron Peters has worked with several communities in Fulton County during 2016. He was invited to participate in the Sherman's Park Committee in Caroga Lake as they try to determine the best use of property that was once an amusement park. He has also been working with the Village of Northville as they try to increase tourism and development through sctivities focusing on grant sources. CRG was in attendance at a meeting in the Village of Broadalbin. along with representatives from Regional and State Government, as Mayor Christopher made a presentation regarding the potential reuse of a vacant mill property in the village. Ron has also continued to work closely with the City of Gloversville on their downtown revitalization initiative. He was part of the team that developed an application for a grant through the NYS Governor's office. He also spearheaded the initiation of an EPA Grant application for the City. And he organized the team of Gloversville leaders for the development of a Downtown Development Specialist, who would work for CRG but would focus efforts on the revitalization and promotion of the downtown Gloversville corridor.

Throughout 2016, Ron also reached out to Fulton County businesses to better understand their needs and goals. The following is a list of

businesses Ron met with during 2016 for an initial visit. He also continues to work with businesses that he has met with since he started with CRG in October 2014.

Grant Initiatives

Each year, Ron Peters looks for ways to encourage Fulton County businesses to apply for CFA grant funding where applicable. He also looks for ways to provide them with assistance with the application process, which can be difficult to navigate.

Ron also worked on the Microenterprise Grant Programs, which were awarded to Fulton County. A more detailed explanation of this process is listed on page eleven.

Loan Pool Summary

CRG is contracted to administer three revolving loan pools on behalf of Fulton County and the cities of Johnstown and Gloversville. The loan pools are the result of community awards to those entities in the 1980's from the Department of Housing and Urban Development.

The Fulton County CDBG (Community Development Block Grant) and Johnstown UDAG (Urban Development Action Grant) loan funds are overseen by a Loan Committee made up of Fulton County Economic Development Corporation Board Directors. The City of Gloversville Loan Fund is overseen by its own committee, which consists of 4 members appointed by the City of Gloversville and 3 members appointed by CRG.

The three loan pools have assisted start-up businesses, as well as existing businesses, to create jobs, expand their facilities, rehab buildings, and enhance business ownership in Fulton County.

Below is an overview of the active loans in each loan pool as of December 31, 2016. The amount next to the borrower's name represent the original loan amount, not the principal amount owing.

Microenterprise Grant Summary

CRG administers two Microenterprise Grants on behalf of Fulton County. These grant funds were awarded to Fulton County through successful CFA applications. The Microenterprise Grants are awarded on a two-year basis. Both funds were for \$200,000.00 in total. The first fund ran from 2013-2015. The second will cover 2016-2018.

Award recipients must meet specific qualifications in order to receive funding. Among other things, the business must have with 5 employees or less and the owner must complete a required business training class. During 2016, CRG completed follow-up visits for all of the funded businesses from the 2013-2015 program. Ron Peters worked with liaison, Nick Zabawsky, on two remaining unfunded applicants that were new businesses experiencing challenges that affected their ability to draw down their financing. Both received an extension, and one was able to meet the December 31, 2016 deadline and will be able to receiving their funding.

The 2016-2018 Microenterprise program kicked off in the spring of 2016 with a presentation by Ron Peters to a group of 17 local business owners, representing 16 businesses, interested in hearing more about the program. CRG then partnered with the Fulton-Montgomery Chamber of Commerce to host two training sessions for potential Microenterprise Grant applicants. Twenty-two business owners attended these sessions. Ron followed up with these qualified businesses and by year end, collected 5 applications, which are in various stages of processing; one is already approved by New York State. He will continue to process applications until the fund is depleted.

Other CRG Activities

Acquisition of 34 West Fulton Street

Ron Peters began conversing with OHM Laboratories in late 2015 regarding their manufacturing building in downtown Gloversville, which has been unoccupied since October 13, 2011. An agreement was finally reached and on March 16, 2016, CRG was gifted the building, located at 30-34 West Fulton Street, Gloversville. Aside from some minor water damage, due to a frozen drain pipe, the building was in excellent condition. The office section received a thorough cleaning and a fresh coat of paint before CRG moved their office into a corner suite on April 1, 2016.

With the full support of its Board of Directors, CRG plans to transorm this building into business incubator space. They are actively seeking start-up or existing small businesses that are looking for space. Once their business flourishes to capacity, CRG will assist them in locating more suitable space, perhaps at the Tryon Park or another location in Fulton County. Additionally, the building will be renamed, The Center. One suite in the business office space is being reserved as an informational hub for any future or existing Fulton County business owner to reference. As this idea is refined in 2017, more information will be released.

To fund renovations to their new building, CRG applied for three grants during 2016; a Restore New York Grant, a National Grid Grant, and grant funding through Senator Hugh Farley's office. The application processes for these were still ongoing as of December 31, 2016 but it is anticipated that CRG will have approximately \$650,000.00 in grant money to work with during 2017.

In the fall of 2016, CRG acquired its first tenant: Fulton County Board of Realtors. They now occupy suite 110. The Gloversville City Library also entered into a lease agreement for most of the remaining first floor. They will occupy this space during the time that their building is being renovated.









Events and Sponsorships

New York Innovative Communities Network Regional Meeting April 14-15, 2016

Fromerly known as New York State Urban Council, Ron Peters arranged for this group to hold their spring Quarterly Meeting in downtown Gloversville. The event was sponsored by Frontier and the meeting was entitled: Downtowns with a Future – The Making of Places.

Registration took place at the City National Building with breakfast items donated from FAGE, the Holiday Inn and the Hohenforst Family. Opening remarks were followed by morning break-out sessions, which were held at the Chamber of Commerce or at the City National Building. Participants could choose from a workshop on crime prevention or a workshop on marketing events. Lunch was held at the Glove Theatre where a video on the redevelopment of the City of Gloversville was shown to all in attendance. Afternoon sessions included the choice of a workshop on innovative community programming or a "camp-fire" discussion on the challenges of creating a creative class sector in the community. Everyone was then invited on a walking tour of downtown and the day concluded with a dinner event at the Eccentric Club.

Friday's agenda included an Urban Council Board Meeting, breakfast at Mohawk Harvest Cooperative Market & Café, and ended with a statewide and region-by-region coffee chat.

This event was widely praised by both local community members and the press.



Subsidiary Reports

Fulton County Center for Regional Growth was established as the parent corporation to three other organizations in March of 2012. Since then, CRG has been working to become an independent, self sufficient organization. As the assets of these organizations are disposed of, they come closer to the ultimate goal of dissolution. Following is an update of 2016 activities that worked toward that goal.

Fulton County Economic Development Corporation

FCEDC had virtually no activity during 2016 as most of its functions have been transferred to CRG. There are only a couple of items left to finalize before CRG can complete it's goal of closing the organization down.

Crossroads Incubator Corporation

CIC was the real eatate holding company prior to CRG's establishment. The goal to close CIC down made great strides during 2016 with the sale of 110 Decker Drive, Johnstown in January; the expiration of the lease agreement on 160 Enterprise Drive, Johnstown in June; the sale of Estee Commons Apartment Complex at 11 Fremont Street, Gloversville in November, and the foreclosure of two vacant adjoining land parcels off of Union Avenue and Franklin Street.

Remaining CIC owned properties include the Nathan Littauer Perth Primary Care Center; 90 North Main Street, Gloversville; and vacant land on the corner of Prospect Street and Littauer Place. Once these properties are disposed of, CIC can be dissolved.

Crossroads Two Incubator Corporation

CIC II has been under the dissolution process with New York State for all of 2016. It is expected that the process will be complete in 2017.

Outlook for the Year 2017

2017 will be a year for name recognition and branding, branding, branding,

CRG plans to increase the number of events that they host in 2017. With the purchase of a free standing tent and trade show booth, as well as branded marketing items, CRG will have a visible presence at local and national events.

Several events are already being planned, such as a spring unveiling of CRG's plans for the 34 West Fulton Street building, which will be re-named "The Center" as it will house a premier business resource center for all Fulton County entreprenuers. CRG will co-host several events including a second financial symposium with MVEDD, a local Site Selector's Guild event with Fulton County, and a Tryon Technology Park event for CIREB members, also with Fulton County. In the fall, CRG is considering modifying its networking event into a more interactive business event.

The 2016-2017 Membership Drive will continue throughout the year as CRG strives to make its presence in the County known. Ron Peters will continue to reach out to as many local businesses as his schedule allows.

The Gloversville Downtown Development Specialist will be hired in 2017 and begin to develop strategies for the redevelopment of the heart of Gloversville. This is considered a pilot program in the County. If successful, CRG will assist other communities to establish a similar format.
